During the Obama Administration, John served as the President's White House Senior Director for Energy and Climate Change, and previously as the Chief of Staff and Chief Operating Officer at the Overseas Private Investment Corporation (now the U.S. Development Finance Corporation). Outside of Government, John was formerly Managing Director of Economic Policy at The Pew Charitable Trusts, a private equity investor with the Global Environment Fund, and strategy consultant.
